

Call for the release of n. 2 awards to forestry professionals employed by public forestry agencies or private forestry companies, as a contribution to the expenses for their participation to FORMEC 2024

The National Union for Forest Scientific Innovation (UNIF), a non-profit association, in collaboration with the Italian Academy of Forest Sciences (AISF), the DAGRI of the University of Florence and the National Research Council (CNR), former organizers of FORMEC 2023, as part of its aims of promoting scientific research in the forestry sector of particular social and environmental interest and of encouraging the dissemination of research results in the interest of the community, offers a contribution to the expenses in favor of n.2 forestry professionals, employed by public forestry agencies or private forestry companies, who offered a presentation at the FORMEC Conference, held in Gdansk, Poland from 11 to 14 June 2024. The maximum contribution to participation expenses amounts to 450 euro and is intended to cover the registration costs for the conference.

Who can apply

Forestry professionals, employed by public forestry agencies or private forestry companies, who offered a presentation at the FORMEC Conference, held in Gdansk, Poland from 11 to 14 June 2024 (henceforth Formec 2024).

Requirements

Participants must be born after January 1, 1974, hold a degree in forestry sciences or equivalent in compliance with the university system of the State where they received their higher education, be employed on a permanent basis at a public agency or private company in the forestry sector.

Evaluation procedure

Candidates will be evaluated based on:

- Appreciation by the evaluation commission of the report presented at Formec 2024
- CV: the candidate's CV will be considered for the consistency of the candidate's studies and professional
 experience with the subjects of the conference and, more generally, with the forestry engineering community
- In case of equal evaluation, priority will be given to female candidates and younger candidates.

Applications

- Personal data of the candidate (name, date and place of birth, nationality, current residence)
- Current job position with the exact indication of the public or private agency for which the candidate works
